This session will review recent German and EU case law involving copyright claims to stop the publication of confidential and leaked documents; with comparisons to practical newsroom approaches to publishing leaked information. The moderator will call on lawyers from other jurisdictions to share their experiences.

This session will highlight how the right to be forgotten has been handled and applied in past years and recent developments in this area, including recent German case law on the right of publishers to archive news.
